ENROLLMENT CONTRACT FOR ACADEMIC YEAR 2011-2012

Both parents or legal guardians must sign two copies of this contract and return them to the school office. One copy will be countersigned and returned to you.

I understand that my obligation to pay the fees for the full academic year is unconditional and that after September 1st, no portion of such fees paid or outstanding will be refunded or cancelled in the event of absence, withdrawal, or dismissal from the school of the above student. The undersigned parents or guardians agree that if we do not make a payment as required by this Agreement, we will be liable for any and all costs of collection, including attorneys' fees, not to exceed 15% of the outstanding balance of principal and interest.

I understand that in signing this Enrollment Contract for the coming academic year, I am agreeing to accept the rules and regulations of the School, which may be modified by the school from time to time. Furthermore, I agree with the policy of the School that no student will be permitted to take examinations nor will grades and transcripts be released unless an account has been paid in full. I understand that the Head of School reserves the right to dismiss any student if the general conduct, attitude, or habitual actions of that student, on or off campus, or the behavior of his or her parent(s) or guardian(s) is contrary to the interest of the School.

The School reserves the right to use photographs and/or videos of students and their parents/guardians in school publications and advertisements designed for the sole purpose of promoting the School. I waive all rights to the aforementioned without compensation or further consideration.

The terms and conditions of this Agreement constitute the full and complete agreement between the parties. No change, modification or waiver of this Agreement shall be valid or binding unless it is in writing and signed by the party intended to be bound. This Agreement shall be governed by North Carolina law. If any provision of this Agreement is invalid or unenforceable under any applicable statute or rule of law, then such provision shall be deemed inoperative only to the extent that it may conflict therewith and shall be deemed to be modified to conform with such statute or rule of law. Any provision hereof that may prove invalid or unenforceable under any law shall not affect the validity or enforceability of any other provision hereof.

A non-refundable Enrollment Deposit of \$675 per half day student or \$775 per full day student is required upon execution of this agreement. This completed application and deposit fee are required for securing your child's seat in the classroom. This fee is applied toward tuition for the 2011-2012 school year.
